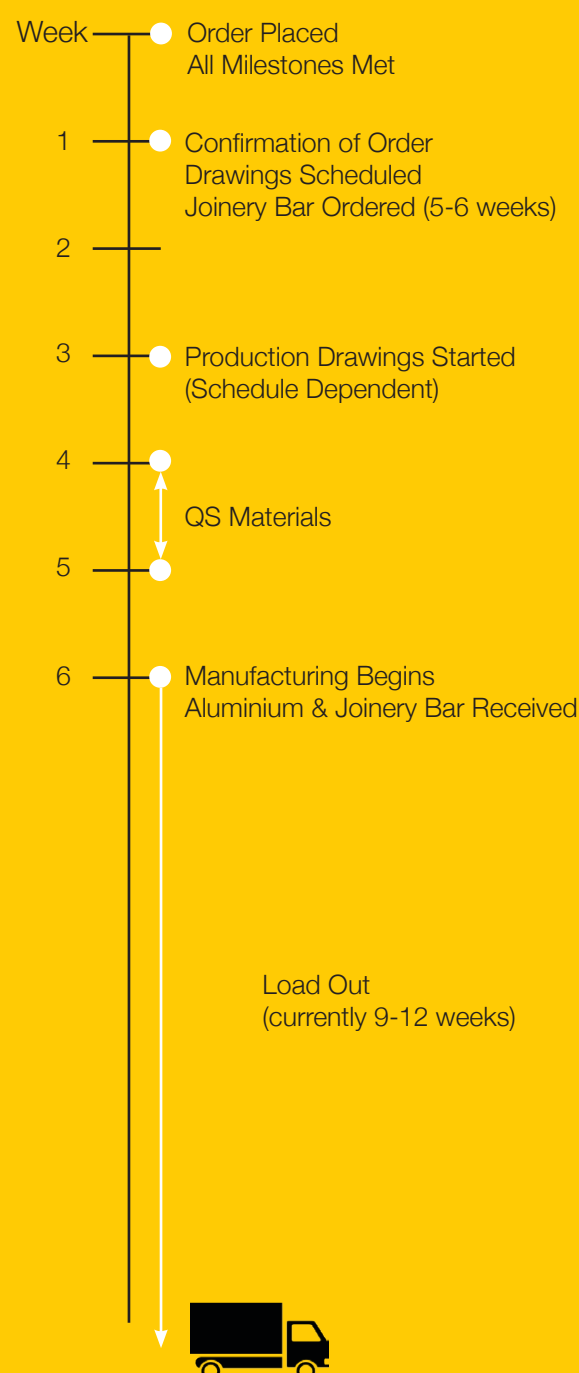

Site glazing procedure – Updated for Southern41 Suite

The transition to Southern41 thermally broken joinery suite within the updated H1 standards has led to a rise in the number of frames surpassing the transport weight threshold. Those joinery frames exceeding the 80kg limit are transported to site without glazing, and a Metro glazier fits the glass on-site.

The Lockwood Joinery department will contact Metro to order and manufacture the glass, setting a tentative site glazing date for 2 weeks after the loadout of components. Metro Glass will get in touch with you to confirm or alter the date to suit. Please be aware that Metro glass require a minimum of two weeks notice for site glazing and ideally a longer lead time if possible.

You must comply with Worksafe Safety Standards for any high - level windows that need to be glazed on site. Metro can provide the necessary working at height equipment if required.

Once your site glazing is complete, you will be invoiced from Lockwood Joinery Dept for the labour and travel charges. This is a direct recharge of the invoice received by Metro, you will not have been charged for this as part of your Lockwood order.

Technical Update – Door Check outs

There has been a technical update posted to the extranet for interior doors. Interior door handle check out sizes have been reduced down to 25mm. On-site, builders will need to use the provided template to drill holes in the door before installation. This ensures a more secure fit for the handle and reduces the risk of it moving over time. 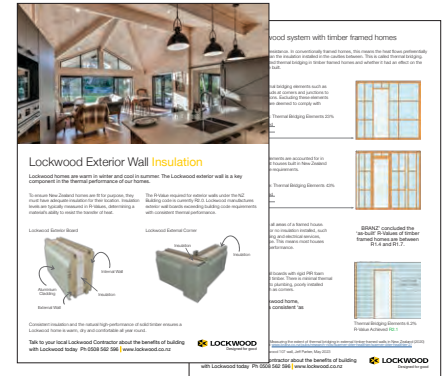

The first of our follow-up packs have gone out and our technical and design teams are working hard in the background actioning requests, updating documents and researching possibilities. The truth about wall insulation

BRANZ conducted a study in 2020 to determine the insulation values of timber framed walls once they were built. The findings were astounding, showing that even when R2.8 insulation is installed in conventionally framed walls, the 'As Built' value was as low as R1.57! This is due to thermal bridging through the timber frames and areas which are unable to be insulated, such as corners and around plumbing.

The Lockwood wall 107mm wall has always been advertised as having an R value of 2.1. In 2022 our CodeMark Auditors sought a review of this value as they were unsure what effect the B Profiles and V grooves have on the 'As Built' value. After investigation, Jeff Parker concluded the Lockwood Wall has a consistent 'As Built' RValue of ***drum roll please*** R2.1. This exceeds the thermal performance requirement for walls in New Zealand, and far out-performs conventional framed buildings. We've compiled the findings into a two-page brochure to succinctly explain this to customers. Security for our customers

We are pleased to launch an added layer of security for our customers' investment in their Lockwood components or ReadyBuilt home. We now have the tools in place to register a financing statement on the PPSR and grant them a security interest through a Deed of Specific Security.

Sounds great, but what does this mean?

A security interest is a legal claim on personal property established to secure payment of debt or other obligation. In this case it secures the obligation of Lockwood to provide the client with their Lockwood components or ReadyBuilt Home. Lockwood registers this security interest through a financing statement on a publicly available online noticeboard – The Personal Property Securities Register (PPSR). The PPSR is managed by the Companies Office and helps businesses and individuals protect themselves financially and reduce their investment risk.

Registering the client's security interest on the PPSR means they have right to take their components or their ReadyBuilt home in the unlikely event that Lockwood, or their contractor, becomes insolvent or goes into liquidation.

With the downfall of several construction and prefab housing companies being highlighted in the media recently, we believe this added layer of security will build trust with our clients and provide assurance to their banks if they require lending.

There is no cost to contractors or clients to register a security interest. If you would like to do so, please let us know when you place your order, and we will take care of the rest.
